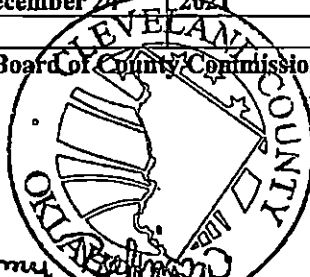

**B.** There was no **new business** to come before the Board for discussion.


**C.** During **Board Members** discussions, newly appointed Bonny Green was welcomed to the Excise Board.


